1. **TO WAIVE ANY AND ALL CLAIMS** that I may have against the Ski Area, the Sponsors, and their directors, officers, employees, agents and representatives, and any volunteers in any way associated with the Event, (all of whom are hereinafter collectively referred to as "the Releasees");
2. **TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY** for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in the Event due to any cause whatsoever, **INCLUDING ANY NEGLIGENCE ON THE PART OF THE RELEASEES;**
3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any property damage or personal injury to any third party, resulting from my participation in the Event; and
4. **THAT** this Release of Liability shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns in the event of my death.
5. That this Agreement shall be governed by and interpreted in accordance with the laws of the Province of Alberta.
6. That any litigation involving the parties to this Agreement shall be brought within the Province of Alberta.

I have read and understand this Release of Liability prior to signing it, and I am aware that by signing this Release of Liability I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators and assigns may have against the Releasees.
